(Revenue \$) In 2016 ASCF awarded two grants to Ilisagvik College, the first to help with the Inupiat Summer Immersion Camp (8 youth and 4 elders participated) designed to give participants a life-changing event that will magnify their knowledge and appreciation of the Inupiaq ways of living.

4b (Code:) (Expenses \$ including grants of \$) (Revenue \$) in college level academic programs, improving in the near and long-term the creation of local labor pool of qualified scientists, technicians and educators.

ASCF awarded a grant to the Boys and Girls Club of Southcentral Alaska and provided funding for 17 Boys and Girls Club sites that participate in Project Learn. Training for 40 Clubhouse staff members, Youth participation was 340 attendees in the clubs.

Additional grants were made to assist Arctic Slope students with the transition from village to college, to assist local Food Banks, to procure and train two K9 unit dogs, and to establish mentoring
